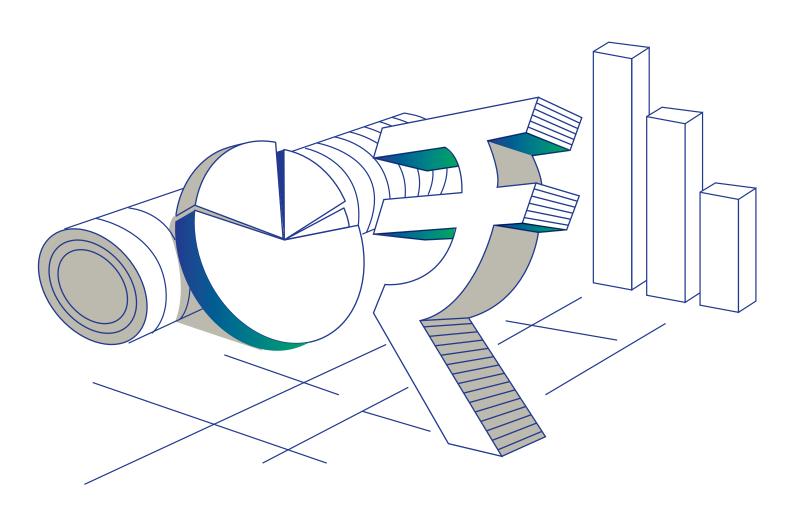

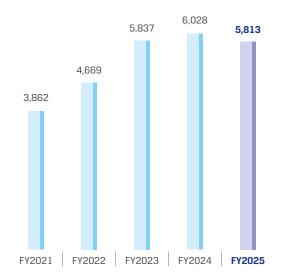




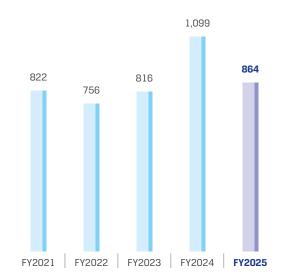

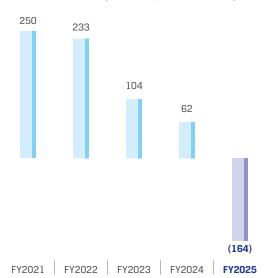
REVENUE (₹ CRORE, Consolidated)
